Point in Time Count 101

- A literal count of all the people experiencing Category 1 homelessness in our community on a single night in January (i.e., at a point in time)
- Opportunity to identify community-level needs/trends

Point in Time Count 101



Sheltered

Emergency Shelter (Includes Hotel/Motel)
Transitional Housing



Unsheltered

Place not meant for human habitation
Vehicles, public spaces, abandoned building,
bus/train station, restaurant, etc.

Point in Time Count 101

Unsheltered Count

- ✗ Hotel/Motel - whether paid for by own funds or agency
- ✗ Unit being evicted from imminently
- ✗ House or apartment
- ✗ Hospital or treatment program
- ✗ Category 2 homelessness

Night Of Count (Blitz)

- *Counting the night of 1/28/26 and early morning of 1/29/2026*

Service Based Count (Multi Day)

- *Counting must be complete within 7 days after 1/28/26*
