New CE Assessment Data Elements



Custom CE Data Elements

- Not required, will not impact vulnerability level or prioritization status
- Can be collected after initial client assessment
- Not intended to replace the SSM
- Is intended to help navigate the housing match and housing search process
- Eventually, elements will appear on the By Name List for easy sorting
- Can be updated as needed

Client Needs & Preferences

- Maximum & Minimum Number of Bedrooms Needed
- Is there a change in the household size expected in the next 12 months
- Does the household required an ADA Accessible Unit
 - *Including Service Animals*
- Would being closer or further from a particular geographic area promote household stability?
- Does the household need a pet friendly unit?
 - *In this instance, Pet Friendly is considered separate from Service Animals*

Critical Documents Storage

- Critical Documents Upload
 - Not a requirement
 - Intended to have access to documents necessary to verify homelessness, disability status, income, etc
 - Serves as a way to backup important documents
 - Can be viewed across providers to reduce redundancy
 - Can upload as many documents as needed
