Maryland Interagency Council on Homelessness

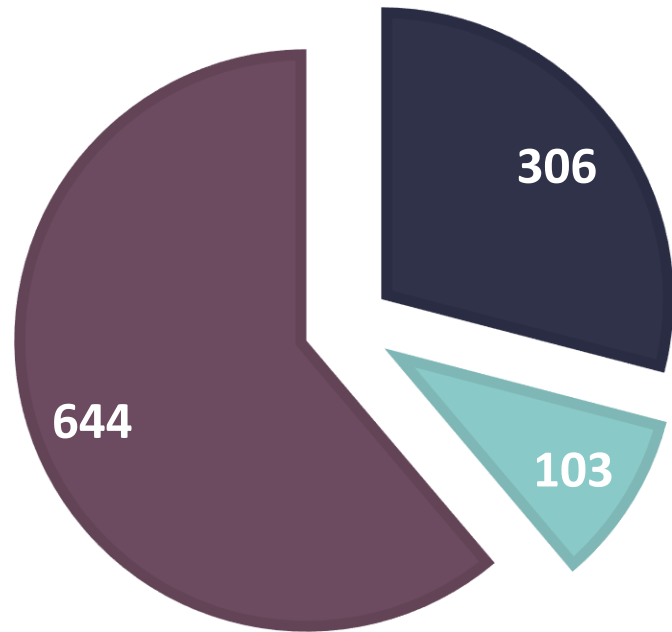
- Brian Wainwright, Harford County, serves on ICH Board in an Advocate role

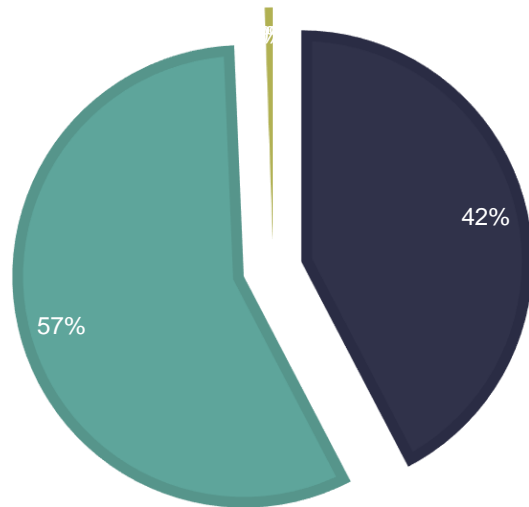

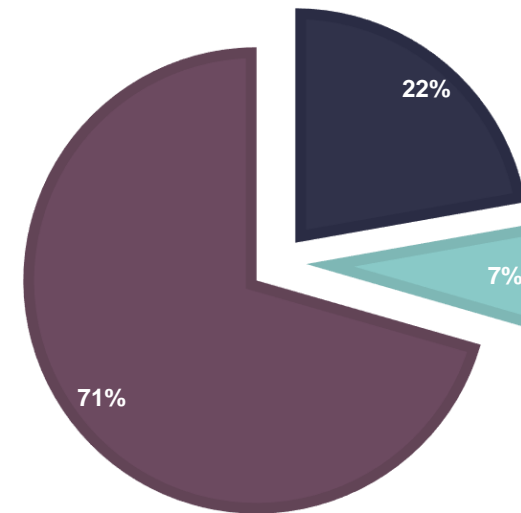

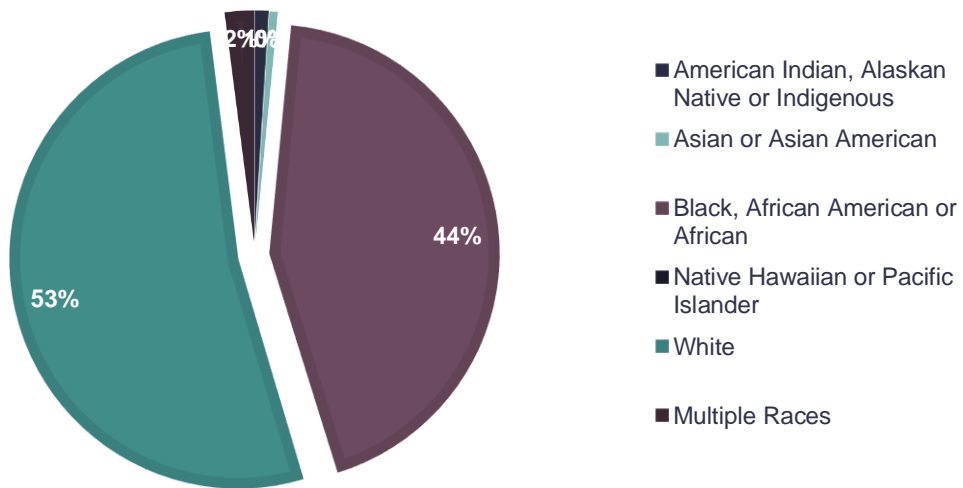

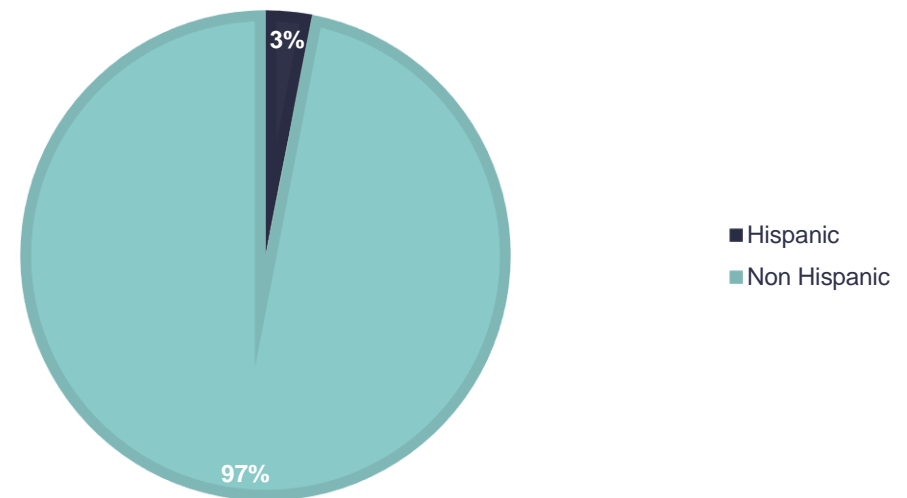

RACE

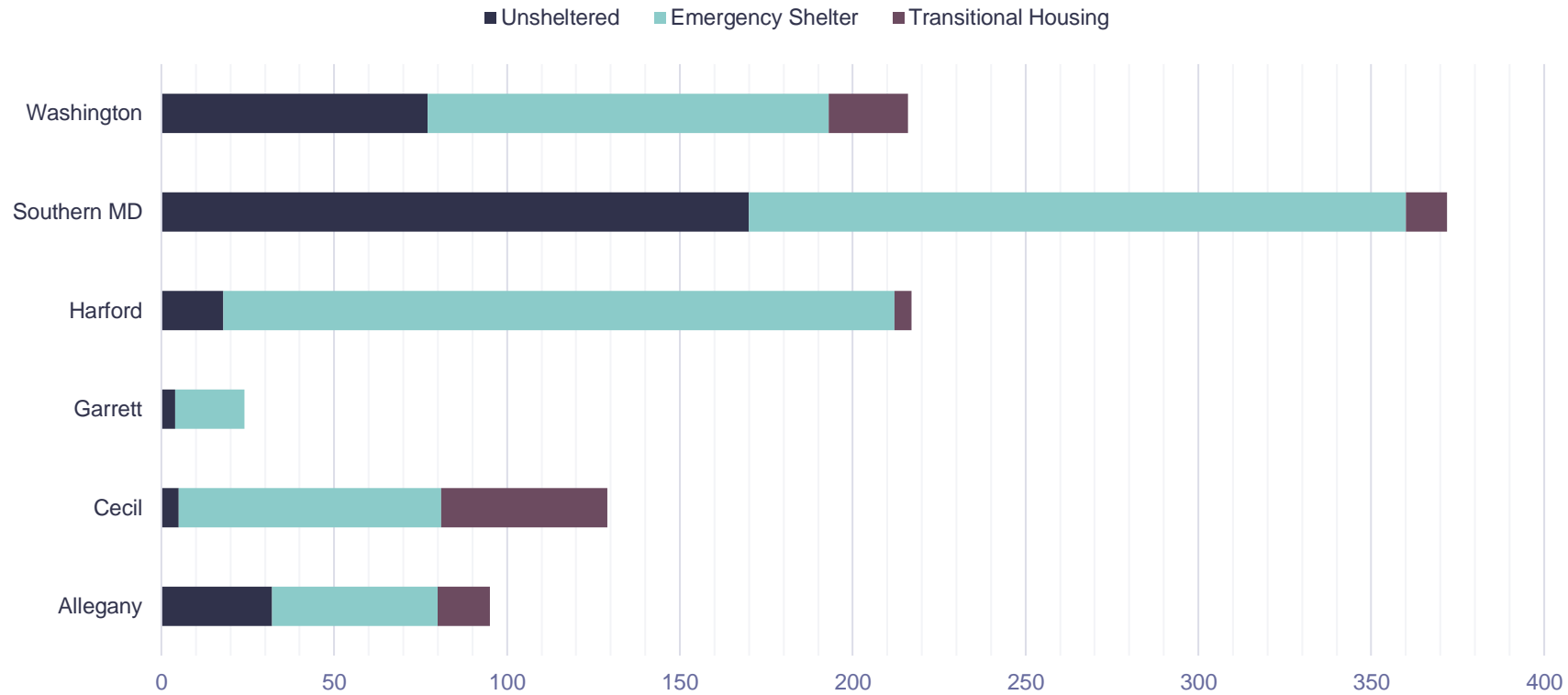


ETHNICITY



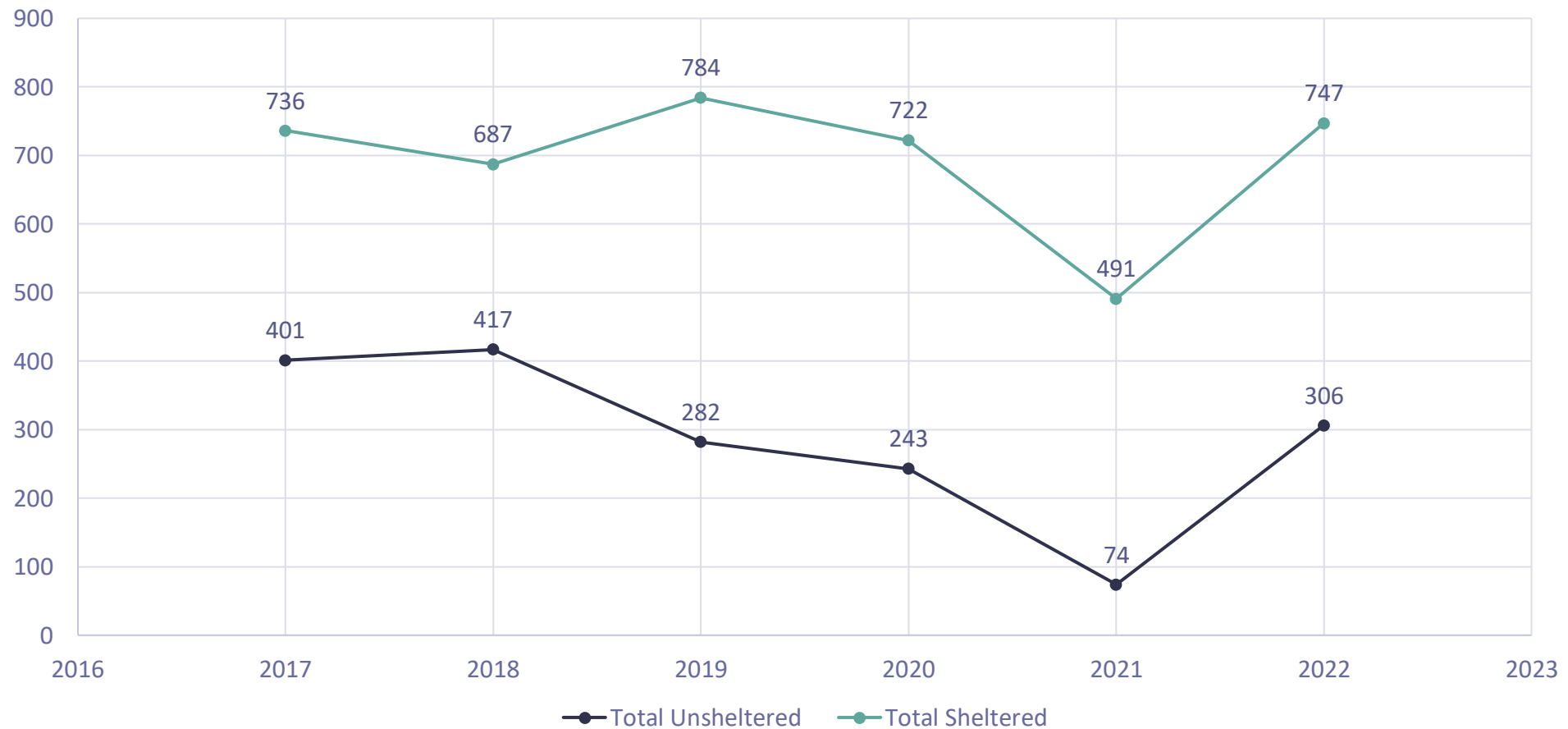

LHC PIT BREAKOUT

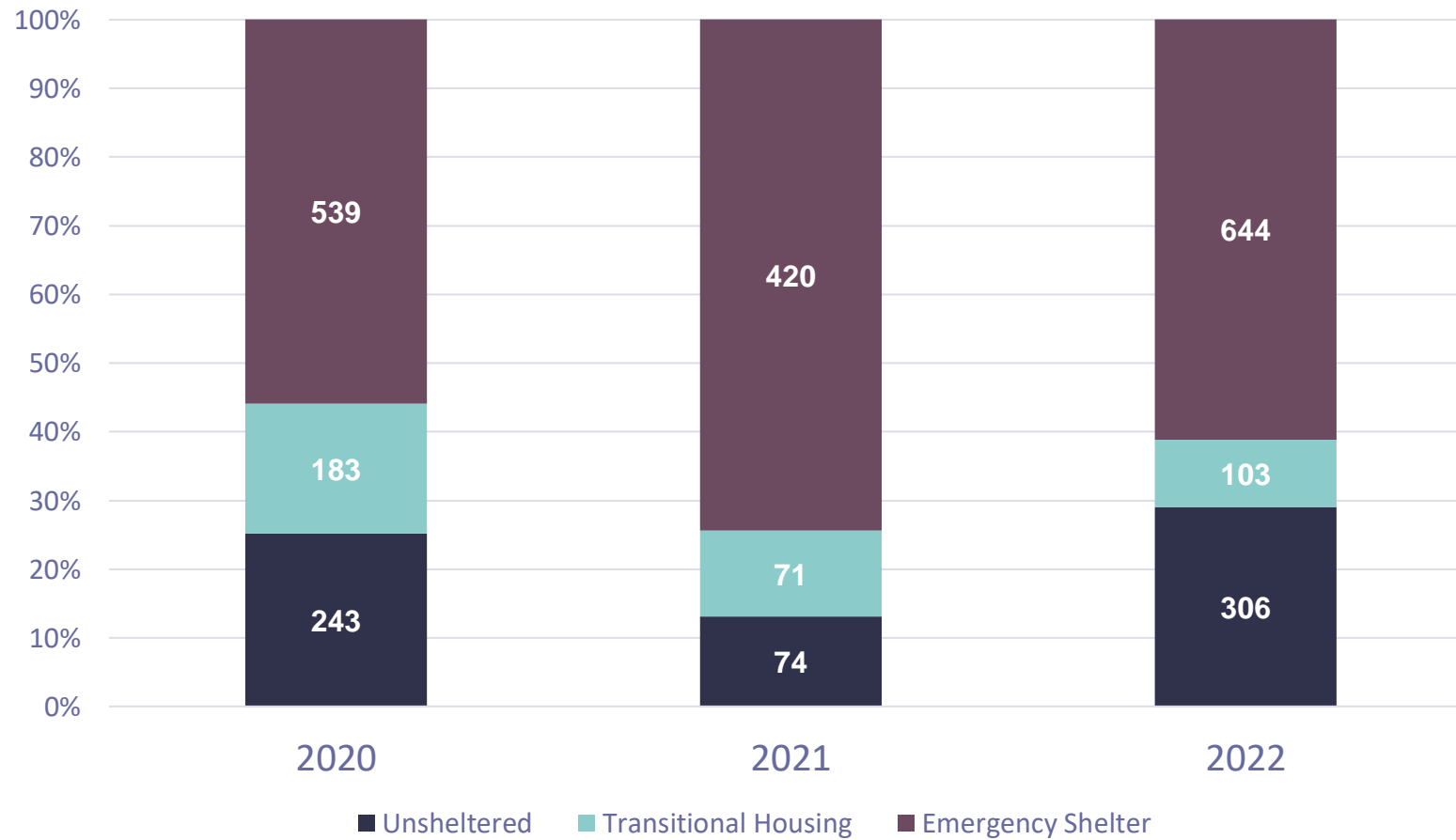

BoS Point in Time: 5 Year Lookback

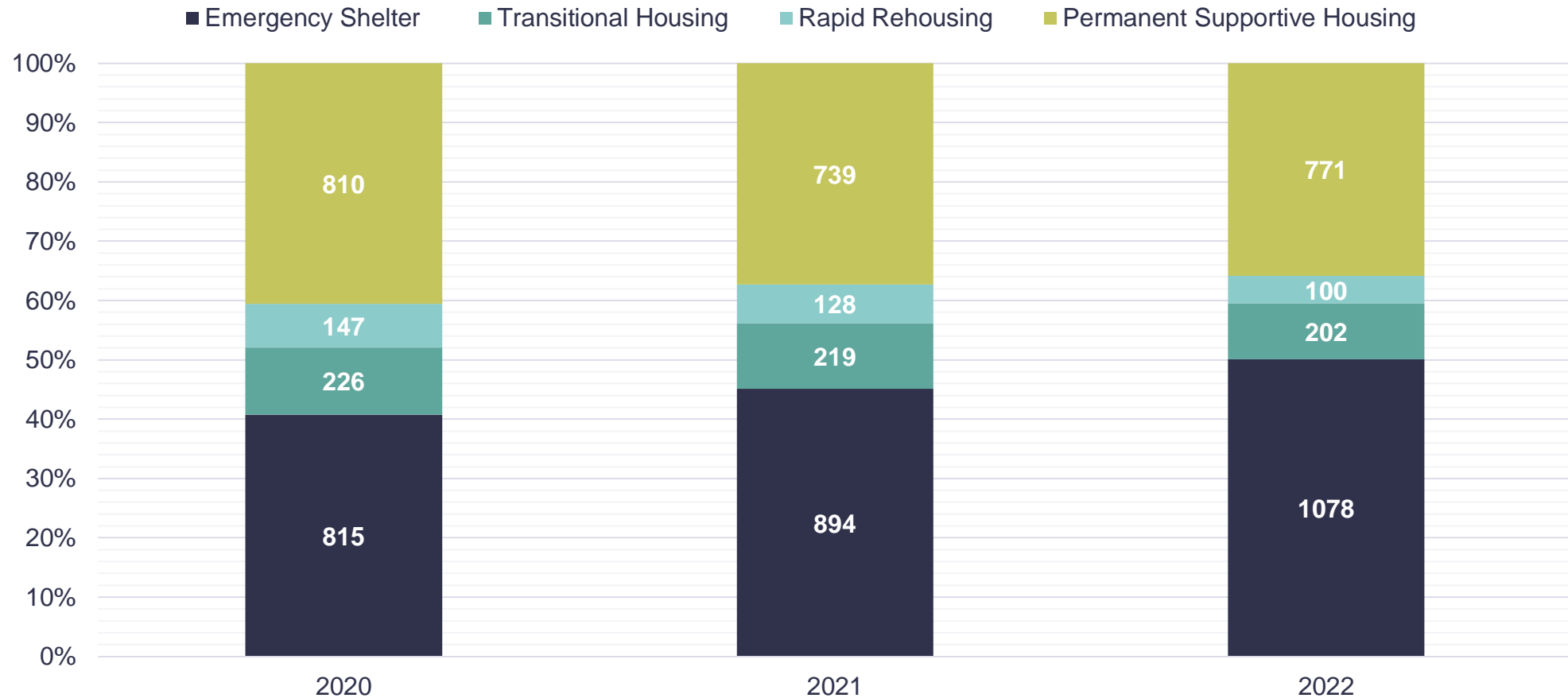

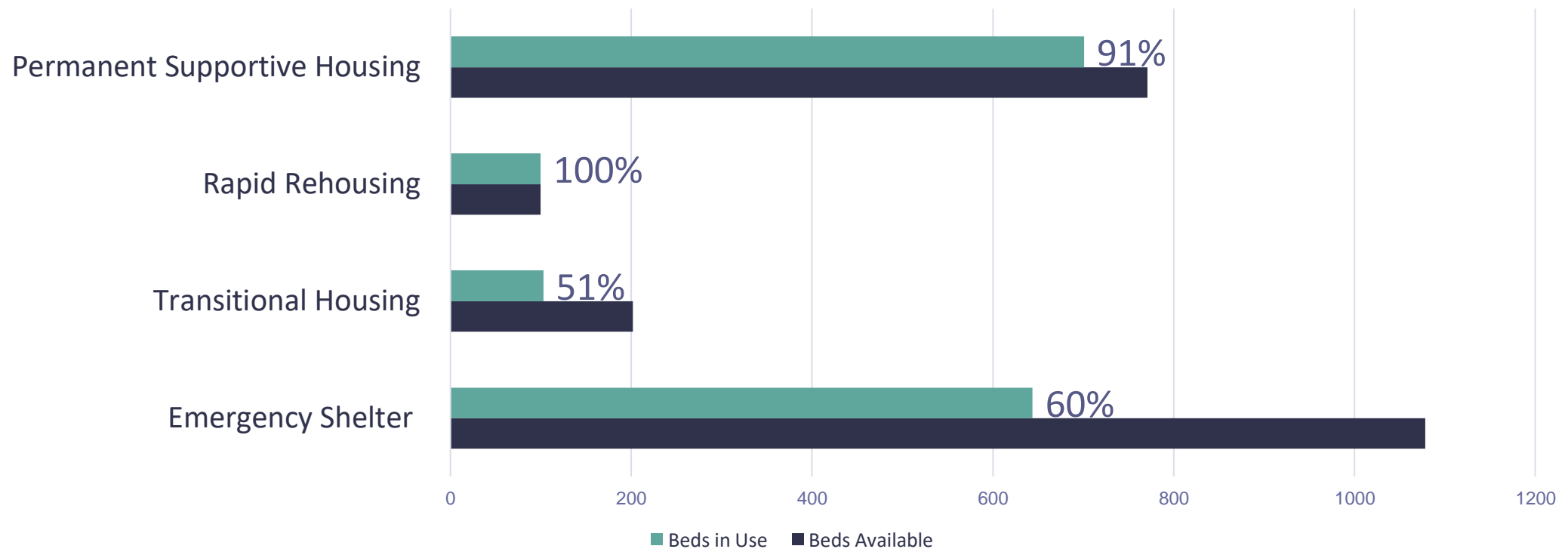
2022 Housing Inventory Count

Balance of State Bed Inventory



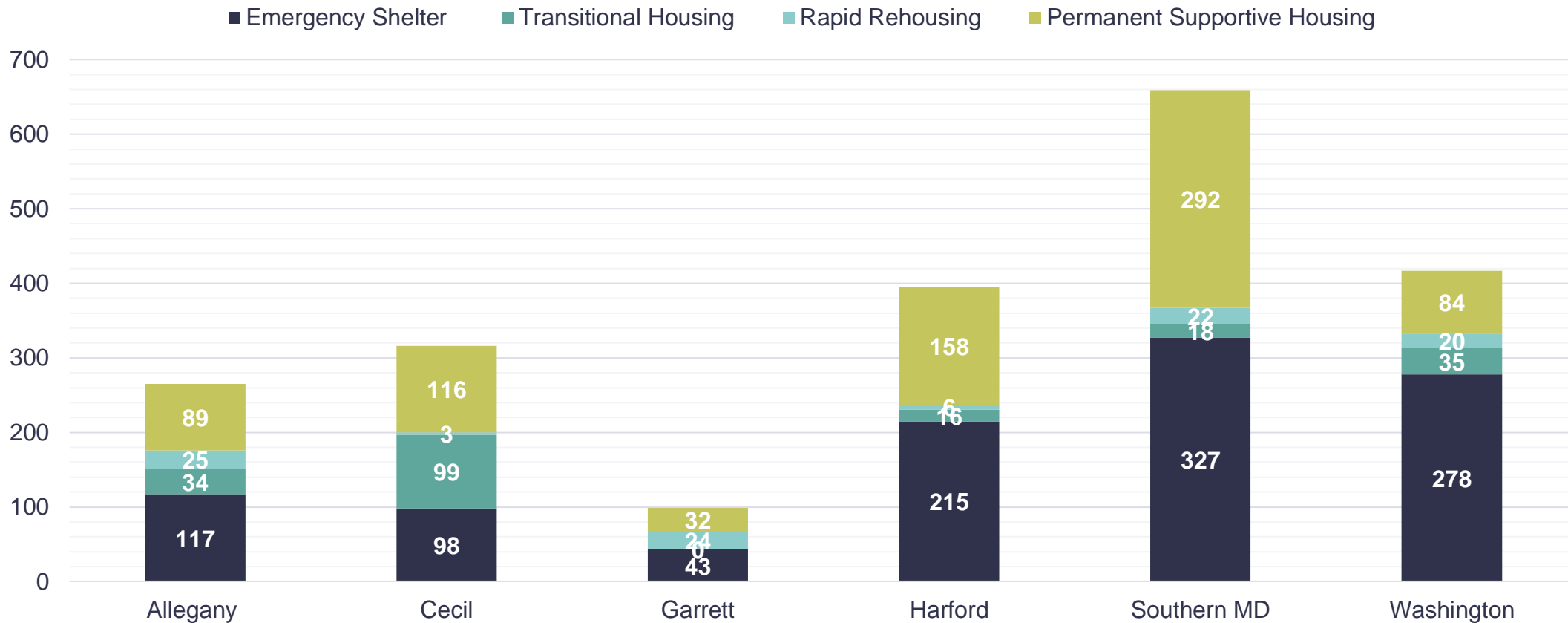
2022 Housing Inventory Count

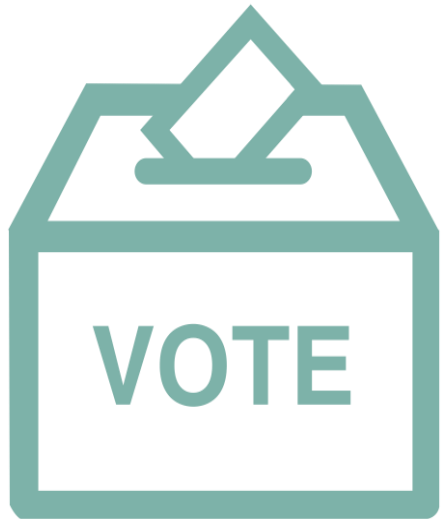

System Performance Dashboard

- **Timeline** - Produced quarterly, provided at CoC Board meetings and on BoS website. First dashboard will include data back to 7/1/2021.
- **Audience/Messaging** - Plain language, easy to understand for public, elected officials, funders, advocates, etc
- **Scope** - Primarily focused on HUD System Performance Measures - will expand over time to include equity and more advanced performance metrics
- **Level of Detail** - Metrics include both BoS-wide data and broken out by LHC (we will explore doing county-level for Southern MD)
- **Trends** - Shows performance measures over time - ex: are things getting better or worse?, identifying seasonal/annual trends

SPM Dashboard Contents

- **Who Experiences Homelessness**
 - Demographic data for clients in outreach, shelter, transitional housing - broken out by race, gender, ethnicity, household type
 - Annual and PIT numbers
 - Prior living situation
- **Reducing Homelessness**
 - First time homelessness/prevention
 - Length of time in outreach, shelter, transitional housing
 - Exits from shelter, transitional to permanent housing
 - Number of shelter, transitional housing beds
 - Shelter, transitional utilization rates
- **Increasing Housing Stability**
 - Permanent housing retention/exit to other permanent housing
 - Returns to homeless system from permanent housing
 - Number of permanent housing units/enrollments/vouchers
 - PSH/RRH utilization rates
 - Increasing income/benefits
